In addition, all students begin the day with religion class, every core class devotes time daily to prayer intentions, schoolwide prayer occurs every morning and afternoon, many projects in specialized classes use a Catholic theme in them, students are exposed to Mass weekly, Exposition, Adoration, Benediction, and Rosary monthly, along with Christian service projects.
